Property and Premises Rules

Regulation 2.5

Unless specifically superseded by law, rule, policy, agreement, or contract; these rules apply within the designated boundaries of all properties and premises owned, controlled, or contracted by the Central Aid Agency; and all persons located therein. To include properties and premises of any subordinate entities, like Primary Commands, Branches, Programs, Affiliates, and Units. For purposes of this regulation and these rules, "security personnel" means any properly vetted, trained, and authorized personnel assigned security related responsibility or authority; including but not limited to United Security Operations Agents, Facility Security Provosts, and their designees.

- 1. Unauthorized camping, panhandling, loitering, or trespassing is not permitted.**
- 2. Use and possession of illicit drugs is not permitted. Use of tobacco is not permitted (unless specifically authorized, and only for non-C.A.A. persons). Unless authorized, use and possession of alcohol is not permitted.**
- 3. Persons must stop or yield when signaled or directed, and must truthfully identify themselves upon request of any C.A.A. official. Including presenting valid proof of identification, certification/authorization, and/or vehicle operator privileges; if requested.**
- 4. Persons shall comply with all lawful/authorized orders, instructions, and directions of security personnel and C.A.A. officials.**
- 5. Persons entering sensitive, secure, or restricted areas may be subject to search as a condition of entry.**
- 6. Persons are to follow all applicable laws, rules, requirements, and regulations. Including obeying all posted traffic control devices, or other rules and regulations.**
- 7. Authorized security personnel and authorized law enforcement personnel may enforce traffic laws and rules, criminal laws and rules, and C.A.A. regulations and rules. Including, but not limited to: making traffic and person stops, taking enforcement action, conducting investigations, issuing summons and fines (citations), and referrals for discipline; when appropriate. Persons must comply with these measures under penalty of trespass, legal consequence, or disciplinary action.**
- 8. C.A.A. vehicles, when equipped as emergency vehicles (lights and sirens), and operated by trained and authorized personnel; are to be treated as emergency vehicles, afforded all the same associated rights and privileges, and yielded to.**
- 9. Persons may be subject to video and audio recording in non-private spaces, or by security personnel. Including, but not limited to: security systems, body-worn cameras, and other recording devices. When possible, the utmost concern for privacy will be given.**
- 10. Firearms are permitted to be carried by those properly trained and authorized in their carry and use; and by those undergoing related training. Unless otherwise posted, or dictated by law or policy.**
